REGULATIONS EFFECTIVE JANUARY 21, 2013

The Cemetery is open for visitation or tending of gravesites from DAWN to DUSK.

NO TRESPASSING IS PERMITTED FROM DUSK to DAWN.

NO PERMANENT PLANTINGS ARE PERMITTED: Trees, Shrubs, Plants or Flowers in turf will be destroyed immediately.

URNS, VASES, POTTED FLOWERS and PLASTIC ARRANGEMENTS are permitted if placed on top of the ground. No holes of any kind permitted for flowerpots.

NO GLASS CONTAINERS ARE PERMITTED.

SUMMER ARRANGEMENTS shall be removed no later than October 1st of each year.

WINTER ARRANGEMENTS shall be removed no later than April 1st of each year.

POSITIVELY NO INTERNMENT IN WOODEN BOXES.

NO LOT CAN BE RE-SOLD TO WESTFIELD TOWNSHIP.

WESTFIELD TOWNSHIP IS NOT RESPONSIBLE FOR ENGRAVING ON MONUMENTS.

WESTFIELD TOWNSHIP IS NOT RESPONSIBLE FOR DAMAGE TO MONUMENTS DUE TO AN ACCIDENT OR ACT OF GOD OR VANDALISM.

WESTFIELD TOWNSHIP RESERVES THE RIGHT TO REFUSE TO INTER A BODY DUE TO UNFORESEEN CONDITIONS BEYOND THEIR CONTROL.

FOUNDATIONS shall be installed by Westfield Township per their minimum specifications. All monument companies shall send a form noting the size of monument. When approved, Westfield Township will notify the monument company of the cost of the installation of the foundation. No foundation will be installed until payment is received. Foundation installations will be at the discretion of Westfield Township. Any person or firm selling monuments that willfully violate Westfield Township rules and regulations will be barred from selling or placing any monument in Friendsville Cemetery. No monuments are permitted except on foundations installed by Westfield Township. (amended 01-21-2013)
THE RATE IS \$.60 PER SQUARE INCH – SEE SPECIFICATIONS ON THE RATES DOCUMENT

ALL BODIES INTERRED SHALL HAVE HEADS TO THE WEST.

ALL MONUMENTS shall be installed at the head of the grave; all second stones must be flush mounted. (amended 06/05/90).

A funeral director shall be present and in charge when a body is interred.

ASHES may be interred in the same grave as another individual. (amended 05/05/90)

A DEED will not be issued until full payment is received. (amended 01/21/13)
