Westfield Fire & Rescue District Regular Meeting April 1, 2013

Trustee Likley called the meeting to order at 6:30pm by asking for roll call.

Trustees present: James Likley, Gary Harris, and Ronald Oiler. Also present Chief Fletcher, Fiscal officer, Martha Evans and resident Wm. Thombs.

The chief read his report (copy is attached)

- ✓ 25 runs for the month of March
- ✓ Medina Co. Fire Chiefs are partnering with Medina Co. EMA in sponsoring Emergency Services Conference beginning Friday evening June 14 and all day June 15. It will be held at Medina High School with various classes. Friday evening will be a Leadership Presentation and all fire, police and government officials encouraged to attend. Topic of lecture "Fear Factors). Friday \$25, Sat. \$85. Online registration will be available later.
- ✓ 162-1 is currently OOS due to airline leak, suspension system and brakes. While it is there annual maintenance will be done. It is at All American Fire in Canton.
- ✓ Various information was provided at the request of Trustee Likley (see list attached)
- ✓ Copy of job description for daytime staffing position, SOG's for on-call station crew, and SOG's for vehicle response was given to the board. Discussion was held concerning who would be filling the positions. Trustee Likley had a concern about the number of members to fill the daytime schedules. Chief responded: it is opened up to our members first, and then we could open to others. Our members just got the info. Trustee Likley: since it is narrowed down to 3 or 4 people; my point is to try to fully staff with our own members first. Chief: we have a minimum of 4 hour increments on the on-call. Someone maybe not to fill the day time staffing but could be on call. We have answered all of our calls at least with 1 person. We must have 2 EMS qualified people to transport. 11 times in the last 6 months we did not transport because of lack of personnel. It is not that we want to add day-time staffing but we need to do this. I am putting in 48-50 hours a week to do reports. I can have someone help with this. Projects that I would like to focus on; (type) SOG's, preplans, expand preplans out to other businesses. Stations repairs that need to be done. Center for service excellence. It is a 2-3 year project. Only 100 fire departments in the country that has that. It's like being the elite of the elite. Without any help these things cannot be accomplished.

Trustee Oiler: what is most important to implement first, day-time staffing or on- call? Chief: both have their merit, just to have the information that a person will be there.

Trustee Likley stated he didn't feel the 5 mile radius stipulation is a concern as we have individuals that are responding now those aren't within the 5 mile radius. I would not let the 5 mile radius be a deterrent. Chief: the on call needs to be at the station or the scene within 5 minutes after the tone is dropped. Trustee Oiler believes the chief knows what we want.

Trustee Likley made a motion to accept the job description for day-time staffing as presented with the addition "department membership and be sworn in", seconded by Trustee Oiler. Roll call: Likley, aye; Oiler, aye; Harris, aye

Trustee Likley made a motion to accept the SOG's for on-call station crew, department membership with the chief to have discretion of the 5 mile radius, seconded by Trustee Oiler. Roll call: Oiler, aye; Harris, aye; Likley, aye.

The chief stated he would take small steps.

Trustee Likley asked if the air truck could be moved due to a residents concern.

Trustee Likley made a motion to pay the bills, seconded by Trustee Harris. Roll call: Harris, aye; Likley, aye; Oiler, aye

CORRESPONDENCE

Trustee Likley reporting:

- o Bill Thorne is back in house and is addressing the contract between the village and the fire district. Trustee Likley met with Mr. Thorne last week but hasn't not heard back from him.
- The property and liability insurance for the fire department will be due in May. Trustee Likley asked Martha to check with insurance company concerning the lease of the building and equipment. Also make sure the insurance provider is aware that there is not a lease agreement and that we can proceed with payment for that insurance coverage with the fire district funds. Trustee Likley's goal is to have this addressed by May.
- o Concern for fiscal officer position posted by Chief Fletchers e-mail requesting anyone interested in being District Fiscal Officer to let him know. The district fiscal officer is Mrs. Evans. I do not believe the office belongs in the fire station. Mrs. Evans may have an assistant but she is the fiscal officer. Mrs. Evans stated: that was our goal. Trustee Likley: the fiscal officer is still responsible. Legal counsel may have to advise us on this matter. This board will make the decision to appoint a fiscal officer if Mrs. Evans retires before her term expires or the voters will elect a new fiscal officer in 2015.

- ✓ Grant for Brush Truck? Chief: We were denied the grant for a brush truck
- ✓ Check the air truck? Chief: It was checked out 2 weeks ago. I moved it to a different spot. We will be a good neighbor.
- ✓ The SOG's have been gone over completely; they just need to be re-typed. They are moving ahead with the project. I will send an electronic copy to each member. Have 3 or 4 copies at the station.
- ✓ Trustee Likley would like to have an activity log. It will give this board knowledge of what our dollars are doing. Daily and weekly log. Chief: I have a monthly calendar, day shift log. Trustee Likley: It gives us valuable information.

The fiscal officer did not receive a quote from THE OHIO PLAN as expected. Wichert Insurance presented a quote of \$8,612 annually. This is our present carrier and our premium is due May 24, 2013. If we receive a quote from The Ohio Plan in the future, we will consider their quote if comparable. Trustee Likley had a concern about the lease of equipment, building and property. Fiscal Officer reported the insurance company is aware of our situation in getting a contract and lease. They are willing to accept payment now and when the contract and lease agreement is consummated the district will forward them a copy.
