Public Hearing Truck Stops of America Car Wash Site Plan and Conditional Use September 29, 2016

Schmidt's application was for an installation of a Modular Car Wash measuring 900 Square feet serving as a single bay car wash system. The modular will be placed on existing paved area and there will be no new storm water drainage since there presently is one on the site.

No additional signage except for a lit menu board with a light pole. The BZA Board discussed this menu board would be considered a sign.

Car wash will be by Burger King and there will be stone stack (same as the gas station).

Landscaping Plans were provided by Schmidt and also the flow of traffic was discussed at this time.

Length of building is 42' by 11' 7" and the sign is 12' by 3'

Sign rendering: 34 square feet for sign and 10 square feet for menu board.

Landscaping will serve as a buffer to the tanks and parking spaces will be illuminated.

ZI Sims discussed that no one has inquired about the application at this time and there are no persons in the audience.

Site Plan is not unusual for the area and appropriate conditional use and there is no for-seen cause for health or safety concerns which are in the spirit of the original site plan.
