ZI Sims contacted the applicant to explain that there is not a full board and they have agreed to continue with the hearing.

Nathaniel Grundy 4336 Sparrow Ridge Massillon, Ohio- Consultant for Medina Materials- Would like to go ahead with the presentation and if needed to request a continuance.

ZI Sims has not received any inquiries regarding this property.

Grundy-President of Mine Consultation (throughout Ohio)

Grundy discussed the 32.8 acres and previous mining on this property from 1977- 2014 (Seville Paving)

CCR received the permit for 2 years and in 2016 the permit was revoked from ODNR.

Medina Materials (MM) has applied for a new permit from ODNR and is waiting for BZA zoning approval. Medina Materials is looking to mine "above the water table" mining of sand and gravel (55 feet of sand and gravel) and they will not go below to the shale or below the water table. Portions of the site are presently at shale level (approximately 6-7 acres). Unusable materials will be used for berms and also for sale.

MM has a bond in the amount of \$10,000 (\$500.00 per acre).

Parking area and drive will be chip and sealed and will not be open to the public. Tonnage will be approximately 50,000 tons per year. Processing materials as needed and truck traffic will be limited (approximately 8 trucks per day Monday thru Friday.) The trucks are permitted to carry 27,000 pounds. Noise and dust will be during the work day (7am-7pm). Dust suppression will be by a water truck. ODNR requires daily record keeping. Temporary lighting may be necessary on occasion. There will be on site processing (crushing product). 70 decibels of noise at 300 feet and there is a buffer of trees.

No utilities run over or under the property.

Portable diesel tank will be on the property. No running water and a port-a-potty will be on the property for employee use.

• Safety plan-is needed from the Fire Chief; this process is under Mine Safety Regulations.

Simmerer requests applicant to have a meeting with the Fire Chief and a letter.

• Safety signage will be on the property and berms and perhaps a fence for keeping people off property. (Berms are approximately 8 feet high and 4-5 feet wide.)

Presently there is a gate on Seville Road and applicant will maintain and/or create a new gate on site if necessary.

- Regulator Authority for Mining-Permit issued (Grundy has met with all of the issues that are
  permitted according to law and the money will be posted in order to receive the bond) according
  to ORC Chapter 1514.
- Reclamation Plan is necessary for the BZA and the reclamation plan has been provided to the ODNR to obtain a permit. They must apply to the ODNR to receive their bond. (Reclamation will be recreation/wildlife habitat) in a rural residential property.
- Inspections are every quarter and 23 performance standards will be checked every year.

Mike Lyons, Assistant Prosecutor provided (exhibit "D") letter pertaining to the Reclamation of Property and the deposit to the Surface Mining Fund established in ORC Chapter 1514.06.
