#### ROADS:

Timothy Kratzer announced the county engineers would like a packet put together indicating what the township would like to have done this year for road surfacing. Tim said that he would get with Lee on this.

Lee spoke with an authorized dealer for the generators and they informed him that it would be ok to run a line to the generators if the pipe was increased to 1".

## CEMETERIES & PARKS:
