# RECORDS OF PROCEEDINGS MINUTES OF THE WESTFIELD TOWNSHIP BOARD OF TRUSTEE'S REGULAR MEETING HELD: SEPTEMBER 6<sup>th</sup>, 2005 @ 8:00 PM

Attendance: Jeffrey Plumer, Timothy Kratzer, Bernie Kindall. Kelly Gregoire, Ron & Marlene Oiler, Jim Likely, Nancy & Russ of 5301 Seville Road & Mr. Sanderson(son of Ruth Sanderson).

Timothy Kratzer opened the meeting by asking those in attendance to stand and pledge allegiance to the flag.

Nancy and Russ of 5301 Seville Road spoke to trustee's regarding their neighbor located at 5294 Seville Road. Nancy and Russ had concerns related to the hours that a home occupation may run. Rodger Link is operating at 2-3 am running loud equipment and cars. Neighbors are not certain how many employees he currently has working for him, but do feel that it is more than 1.
