FISCAL OFFICER

Martha Evans reporting:

A list of bills to be paid in the amount of \$17,038.37 was presented (attached).

Trustee Harris made a motion to pay the bills, seconded by Trustee Oiler.

Roll call: Likley, aye; Harris, aye; Oiler, aye.

Fund Status: Checking; \$402,852.09 Investment; \$536,436.50

<u>Correspondence</u>: Various area meetings and Community Block Grants available through Medina County Commissioners.

Martha had spoken to Bill Thorne this evening and the resolution for resident soft billing and the fire contract is in the draft stages and we should have it within a week.

RESOLUTION 2010-11 A RESOLUTION AGREEING TO PARTICIPATE IN THE CHIPPEWA AREA LAND USE STUDY FACILITATED BY THE MEDINA COUNTY DEPARTMENT OF PLANNING SERVICES

The concept of this resolution was discussed and a motion to agree at the March 15th, 2010 meeting but the fiscal officer was asked to get a sample resolution from the planning commission and proceed accordingly. The resolution was received and prepared. Trustee Harris offered Resolution 2010-11 and moved the adoption of same, seconded by Trustee Oiler.

Roll call: Oiler, aye; Likley, aye; Harris, aye.

RESOLUTION 2010-12 A RESOLUTION TO AMEND PERMANENT APPROPRIATIONS FOR FIRE

LEVY FUND 2010. This resolution is to amend the appropriations to be less cumbersome in view of the fact that the Village of Westfield Center will be managing the fire fund and the township will be making payments.

Martha gave the trustees a report that shows the township has paid to the Village of Westfield Center per the invoices \$20,537.55 since Jan. 1, 2010, therefore we are short \$8,196.28 for the 1st quarter. The second quarter would be due sometime in April in the amount of \$36,930.06 (\$28,733.78 + \$8,106.28). We would pay again in July and again in October if the contract is mutually agreed upon. The amount that has come into the fire levy fund thus far is \$45,846.98 leaving us with a \$11,620.38 short fall. The tax revenue is still coming in.

Trustee Oiler made a motion to adopt Resolution 2010-12, seconded by Trustee Harris. Roll call: Likley, aye; Oiler, aye; Harris, aye.

Lee related to the trustees and audience that the township cell phone plan was updated at a cost of \$69.99 per month which is \$30.00 less than the present plan. The only change was this plan has only 450 min to or from land lines but most of the time it is cell to cell. In May the phone would have the capability to take a picture then send it e-mail immediately. Also with Nextel you never have a roaming charge in the US.

THE MINUTES OF THE MARCH 29, 2010 MEETING WERE TABLED BECAUSE 2 OF THE TRUSTEES DID NOT HAVE THEM IN HAND UNTIL TONIGHT.

PARK/CEMETERY

Trustee Likley reporting:

- > Has one price for fence at cemetery but will be looking for additional quotes
- Intends to see what fence is in storage at the township garage that could be incorporated into the project.
- > No estimate has been sought to trim down the hill at the cemetery
- A cement contractor has been contacted concerning the sidewalks in the park.
 Will get with Pat Edington to look at some of the repairs in the park. No quote at this time
- Mr. Oiler asked about the brick engraver for the fund raiser. Mr. Likley has turned that project over to the Eagle Scout that is anticipating doing the flag pole at the cemetery but will try to touch base.
- Ms. Edington from the Village of Westfield Center left the park maintenance proposal for 2010.

Mr. Likley wants to review the proposal before making a decision. There were some increases. PARK PROPOSAL TABLED UNTIL NEXT MEETING BECAUSE MR. LIKLEY WOULD LIKE TO SIT DOWN WITH PAT EDINGTON AND GET SOME ADDITONAL INFORMATION.

FIRE DEPARTMENT

Trustee Oiler reporting:

The next fire committee meeting will be April 22, 2010 at 7:00 pm. The last report there were about 15-18 resumes` for the fire chief. The time line for fire chief resumes` to close was Friday, April 16, 2010 at 5 pm.

The Village of Westfield Center council voted unanimously to manage the single fire fund and to be the employer of all fire department personnel and Martha to receive all soft billing revenue. The village agreement is good until the end of 2011. If an unincorporated fire district is formed and a levy to support that district passes, the township can be the manager of the one fund and employer of the fire department personnel.

ROADS

Lee Evans reporting:

- \checkmark The following roads need to be Chipped and Sealed this year
 - Ballash from Kennard Rd. to Buffham Rd.
 - Buffham Rd. from Westfield Rd. to Lake Rd.
 - Kennard Rd from Western Township line to Friendsville Rd.
 - Kings Creek Dr. and cul-de-sac
 - Mudlake Rd. from Daniels Rd. to Hulbert Rd.
 - Daniels Rd & Stuckey from Rt. 3 to Mudlake Rd will be shimmed 4' on each edge
- ✓ THIS IS JUST A QUOTE OF \$88,331.40. I need to forward this to the county engineers office and have them work up a bid package and put out for bid and then open the bids as soon as we can.
- ✓ Some of the roads that are going to be sealed will need to be shimmed with asphalt before the sealing at a cost of about \$15,000.
- ✓ The chipping and sealing is like a band-aid to preserve the roads until we can top it with hot mix or motor paving due to the fact they had been left go.

Mr. Likley asked about Issue I funding for Buffham Road and requested that Lee pursue that issue. Lee did not know where the county stands on that project.

- ✓ Buffham Rd bridge over Chippewa Creek east of Lake Road is being surveyed by the county, possibly replacing and moving the bridge out of the curve.
- ✓ No report from CSX on the bridge replacement on Mudlake Rd. Possibly start in June after the rainy season because of the flooding.

ALL TRUSTEES AGREED TO PERMIT LEE TO SUBMIT THE ABOVE MENTIONED ROAD PROJECTS TO THE COUNTY ENGINEER TO HAVE A BID PACKAGE WORKED UP AND PUT OUT FOR BID.
