- Collaboration will be needed between Village & County for snow clearing after U-turn changes.
- Lafayette Township has not been needed to assist with snow removal.
- Ash tree removal needs to be addressed due to their fragile state.
- Sign orders have been submitted by State to manufacturer this includes posts and hardware. County has a driver for the posts. Signs will be recoded at time of installation.
- Bids for stone & mowing will be opened at the next meeting.
