Regular Meeting August 21, 2017

Trustee Schmidt called the regular meeting to order at 7:00 PM. Roll call: Thombs – aye, Schmidt – aye, Likley- aye.

Zoning Report Carolyn Sims

- A lot reconfiguration request by the Medina County Park District. All lot split fees are waived since it's another government entity. Creating 2 lots, interior lot was reviewed by Mike Lyons since it did not meeting zoning code in the township. Mr. Lyons stated that Ohio Revised code supersedes Township code therefore it is an approvable lot split. Trustee Thombs & Likley will sign off and Trustee Schmidt will abstain as he is an adjoining property owner.
- Buffham Road residents called to inquire regarding 55 gallon drum storage at a neighboring property at 6571 Buffham Road. This may not be zoning issue but rather a Medina County Department of Health issue. ZI Sims met with the property owner who was very receptive and began to clean up the property and is now in zoning compliance. The MCHD responded regarding the contents of the barrels being a vegetable oil based and should not be reused. Doug MacIntyre property owner was not aware of the zoning and will often store empty barrels. He will keep them out of sight going forward.
- A zoning certificate was issued for the north side of Buffham Road. Another certificate was issued for Greenwich Road just east of Friendsville Road.
- Trustee Schmidt was questioning if the manufactured house on Kennard Road just before Lake Road was issued a zoning permit. ZI Sims will research and report back.

Fire Station Report

- Thombs filed necessary documents at the Board of Elections for the November Bond Levy. Correspondence was received from the Medina Board of Elections for a verbiage review. Trustee Thombs and Schmidt compared the information and found it satisfactory. Trustee Likley requested that the Medina County, Ohio needs to be included with Westfield Township.
- There have been no updates from DS Architects with regard to floor plans. Trustee Likley will follow up as to a timeline for a presentation.
- Research regarding the need for a new political action committee is required. Trustee Schmidt believes that it will not be necessary.

- Solid Waste no updates, next meeting to be in September, 2017. Montville Township passed their recycling service and contracted with Kimble. This is a mandatory service and residents will be given recycling containers paid for from grant funds. There will be 2 trucks one for trash and one for recycling. There will be options for levels of service but Kimble is the only provider.
- Cell Tower No further updates from Mike Lyons. The last 2 deposits (Aug & Sept) have been higher due to the contract renewal as of 8/1/2017 and the 15% escalation adjustment per the company (\$257.51).
