Comprehensive Plan Presentation

The Board reviewed and discussed the proposed changes to the following sections of Article IV (Signage): Sections 403 A., 404 F., 404 G., 404 H., 405 K., 406 A.1., 406 B.1., 406 B.2., 406 B.3., 406 B.4., 406 B.5., 406 B.6., 407, 407 C.1., 407 C.2., 407 C.3., 407 C.4., and Article VIII, Section 804 A. The proposed text amendments are attached as Exhibit A.

John Miller made a motion to send the proposed text amendments (Exhibit A) to the Medina County Department of Planning Services for their review. Scott Anderson seconded the motion. The motion was unanimously approved.
